SCOPE OF WORK

1. Contractor will provide weighbridge rental services for 4 days of EID-UL-AZHA 2019 (1 day before EID and 3 days of EID-UL-AZHA 2019) at designated sites.
2. The contractor will provide the 4x rental weighbridges services at:
 - o 1x Siggian site.
 - o 1x Sundar OR decided by LWMC
 - o 1x Tibba OR decided by LWMC
 - o 1x near Mehmood Booti site.
3. The contractor will be responsible to manage the minimum 3200 trips at rental weighbridges.
4. Generators\UPS will be provided by the contractor in electricity load shedding hours.
5. Above trips will be paid on per trip basis where minimum 1600 trips payments shall be ensured by LWMC
6. Final disposal sites will be decided by the LWMC at the time of contract.
7. The contractor will ensure that there will be no downtime.
8. The contractor will share his contract No. and will be available on call 24/7.
9. The contractor will visit the site in case of emergency and as and when required by LWMC.
10. The contractor will get the permission of installation of IT equipment like IP cameras etc. at rental weighbridges.
11. The contractor will arrange proper location, sitting plan and seats at rental weighbridges.
12. The contractor will arrange the tent/shed at rental weighbridge if required.
13. The contractor will get the job completion certificate from LWMC.
14. In case of failure of services as required by LWMC then deduction will be made from submitted invoice.
